

## Weekend Permissions and Release Form

For the year 2008–09, or until permission is changed by written notice from his/her parents or legal guardian,

- 1.** Student may come home for a weekend without further permission from us. (If student has additional residences beyond the primary address and the student has permission to visit without further permission, please indicate the address of these residences on the reverse side of this sheet.)
- 2.** Student may accept a weekend invitation from family friends and relatives listed on the reverse side of this sheet. **(IF YOU CHECK YES, YOU MUST LIST THE INDIVIDUAL NAMES ON THE REVERSE SIDE.)**
- 3.** Student may accept a weekend invitation from the family of another NMH student and ride with the parents of said NMH student.
- 4. For seniors only:** Student may leave school for a weekend overnight to visit colleges as part of the college search process as planned in conjunction with his/her NMH college counselor. (This permission does **not** allow the student to miss classes or to be away from school on a weeknight.)
- 5. For seniors with privileges only:** Seniors in good standing (no probation and fewer than six absence points) may leave campus for a weekend overnight to any destination without further permission from us.

**Permission from parents for those activities that have not been authorized above must be received either in writing or by phoning the deans office by Wednesday at 5 PM prior to the weekend. The Overnight Parental Permission Form can be downloaded at the NMH website.**

- Notes: (A) Drivers must be listed on the Automobile Permission Form. Otherwise, parents must give specific authorization each time a student is being driven to his or her weekend destination.  
 (B) **Parents must authorize permission by letter or phone call each time a student requests to stay overnight in a hotel/motel.** This communication is not required in the case of a school-sponsored trip.
